Notice is given that a **Special Meeting** of the Board of Directors (Board) of the Brush Country Groundwater Conservation District to be held on **Tuesday, April 28, 2020**, commencing at **9:30 a.m. via Telephone and Videoconference** pursuant to Texas Government Code, Sections 551.125, 551.127 and 551.131, as modified by the Governor of Texas (Governor) who ordered suspension of various provisions of the Open Meetings Act, Chapter 551, Government Code, effective March 16, 2020, in accordance with the Texas Disaster Act of 1975. Under his proclamation of March 13, 2020, the Governor certified that the COVID-19 pandemic poses an imminent threat of disaster and declared a state of disaster for all counties in Texas. The COVID-19 pandemic makes it difficult to convene a quorum of the Board at one location with the public. The Board of Directors of Brush County Groundwater Conservation District (the “District”) met in regular session, open to the public, on February 25, 2020 at the Brush Country Groundwater Building 732 W. Rice Falfurrias, Texas, in accordance with the duly posted notice of said meeting.

1. The meeting was called to order at 9:30 a.m. and the roll was called of the members of the Board of Directors. Six Board members were present at the meeting:

Six Board members were present thus constituting a quorum for agenda items where action was taken by the Board, all Directors present voted. BCGCD General Manager Felix Saenz was present as was the legal counsel Bill Dugat, administrative assistant Maggie Castillo and BCGCD General Manager Trainee Luis Pena. Guests in attendance were Robert Howard Brush Country Consultant.

Motion made by Bill Botard, second by Paul Goranson to approve the minutes, motion carried.

Mr. Felix Saenz mentioned that he would attend Duval County’s GCD meeting February 26th, at 6:00 pm in Benavides Agenda attached
 - b. Permit pumping report for 2019
Mr. Saenz mentioned that we have 30 permitted wells, took lots of time and work to prepare report, majority of permittees cooperated and responded quickly, a few were difficult.
 - c. TCEQ petition of inquiry hearing Starr County GCD on February 13th, 2020 in Austin, Tx. Final review of review panel’s recommended negotiated agreement. Lonnie Stewart read Scotty Bledsoe’s letter. Tom Koenecke, Reyna Guerra, Mike Gershon

legal counsel “Starr County GCD met several times, agreed to a timeline, have to update management plan, get office personnel, hire an employee independent from county, agreed to sign GMA 16 interlocal agreement and pay \$6,000. Reyna Guerra president, Tom Koenecke vice president, Rose Benavides board member, Raul Villarreal new member, Noe Benavides new member

- d. Mr. Saenz made and collected production permit pumping reports.
 - e. Mr. Saenz attended the TAGD meeting in Austin on January 30-31 2020. New faces, George Gonzalez new Duval County GCD manager, Leah Martinson gave financial report on solid ground, Leah mentioned a 5-year plan to increase funding. Mr. Saenz mentioned that “Larry French with the TWDB spoke about administrative considerations, review the management plans, provide a checklist for the DFC’s. Mr. Saenz mentioned that there was a panel discussion on similar rules pressure from legislators, some instances where the rules cannot be the same, completely impossible, carry on how and why are rules are different. Mr. Saenz mentioned that Steve Wallander USDA will be send out an irrigation survey, 24 states with lots of irrigation. In Texas the Ogallala Aquifer, surface water in the valley. On GMA reports, everybody started the 3 rounds of the DFC. Mr. Saenz mentioned that James Beach our consultant, and James Hutchinson, cover most of the state TAGD members, also Intera.

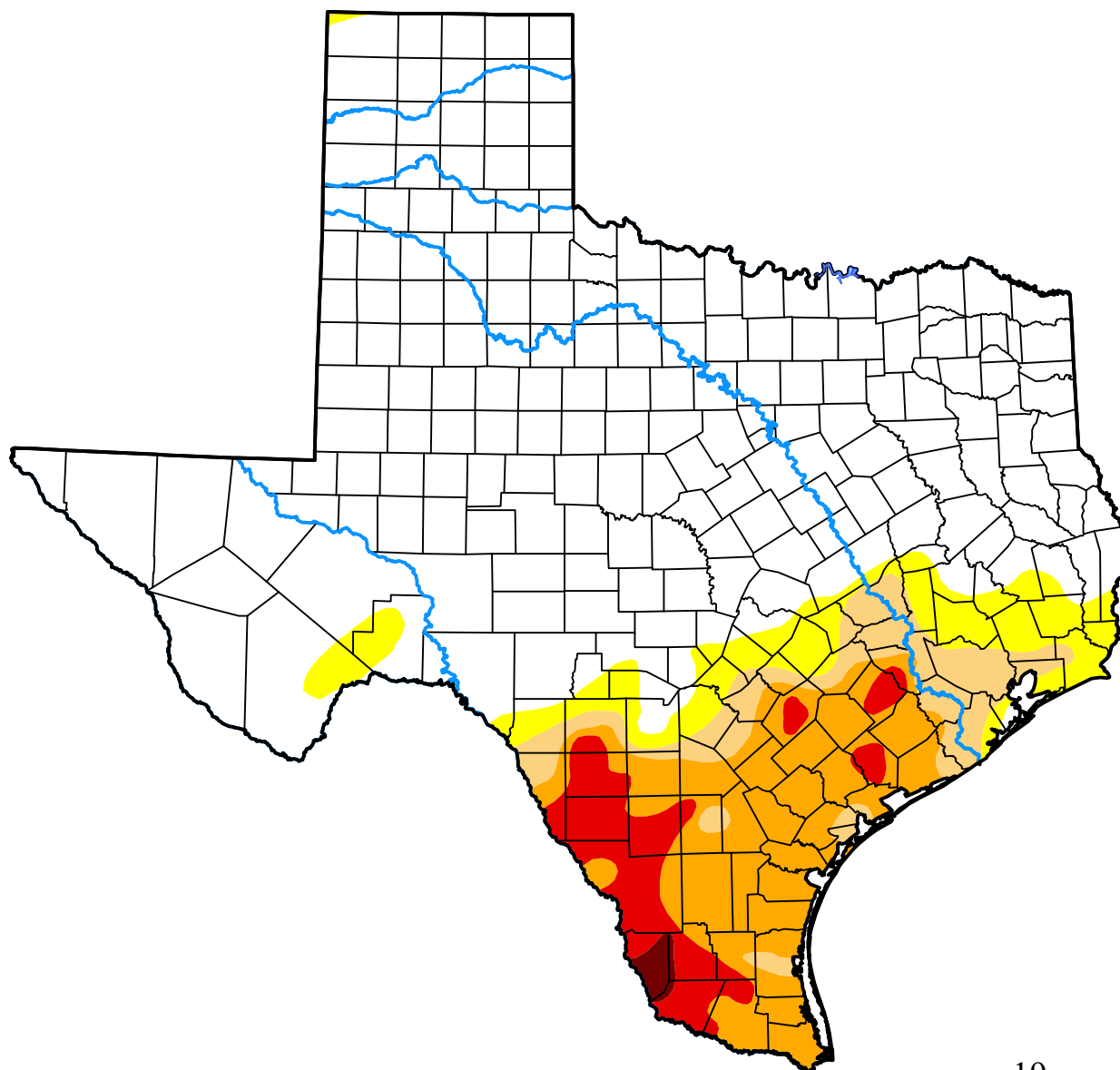
